

TERMS & CONDITIONS



1. Payment and your signature constitute your acceptance of these terms and conditions.
2. Following receipt of your booking form and payment, Activate Sport will send you an email to confirm your booking. If an email address is not available a letter will be sent.
3. A 2% transaction charge will be added to any credit card booking
4. Activate Sport will accept staged payments. Any early bird offer is not valid with staged payments and 30% of the total value must be made upfront.
5. Any child registered for an Activate Sport camp must be at least 4 years of age at the time of the camp, in full time education and under the age of 15.
6. Cancellations are subject to the following charges:
 - Less than 10 days notice – 50% refund
 - On or after the camp start date – no refund
7. If exceptional circumstances arise and it's necessary to cancel a camp then you will be offered the choice of a transfer to an alternative camp or a full refund.
8. Neither Activate Sport nor any of its staff nor persons involved with the organisation of camps accepts liability for the personal injury or death of any participant unless caused by its negligence. Neither Activate Sport nor any of its staff nor persons involved with the organisation of camps accepts liability for any losses or additional expenses incurred by any participant or their parents or guardians due to injury or sickness whilst at an Activate Sport camp, weather, strikes, war or any other cause beyond their control.
9. Activate Sport reserves the right to modify a programme due to adverse weather conditions, low attendance or other unforeseen circumstances.
10. If a parent or guardian would like to make a complaint to Activate Sport then they should contact the office by phone, email or written post. The complaint will be dealt with within 48 hours of it being lodged. A full and detailed copy of our complaints procedure is available to parents or guardians on request.

Although Activate Sport will take every reasonable step to avoid injuries being suffered by participants, there is an inherent risk of injury in sports and activities on our programme. By signing below, you confirm that you are the parent or guardian of the child listed above and have custody and control of him/her and you confirm that:

- You have read and accept all of our terms and conditions.
- You irrevocably consent to: your child's participation in their chosen programme, your child being photographed whilst at the Activate Sport camp, and that such photographs can be used in future promotional material produced by Activate Sport, and data relating to your child collected by Activate Sport in connection with the Activate Sport camp being used for the purposes of the Activate Sport camp and associated promotion.
- You accept that there is an inherent risk of injury in all sports and activities in our programme.
- You accept that we will only administer prescribed drugs, e.g. antibiotics or inhaler, to your child during the camp with your verbal and written consent at the start of the camp.
- You consent that we may call upon emergency medical advice for your child if an incident requires it.
- You accept that you must inform us on the application form that your child suffers from anaphylaxis. We will then follow the procedure we have in place for this.
- You consent to trained first aid personnel caring for your child in the event of an accident.
